- 4. Interested Bidders shall submit their bids electronically through e-GP portal https://www.bolpatra.gov.up to the office of Health Insurance Board on or before 12:00 Noon, on 2077.11.28.
- 5. Bids shall be opened in the presence of bidder's representatives who choose to attend 2:00 PM on 2077.11.28 at the office of HIB, Teku, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security as mentioned above which shall be valid for minimum 30 days beyond the bid validity period.
- 6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid security validity shall be recognized with effect from the original bid submission deadline.
