- 5. Interested Bidders shall submit the electronic Bids through e-GP portal www.bolpatra.gov.np/egp to the office of Health Insurance Board on or before 12:00 Noon, on 29 March 2022.
- 6. Bids shall be opened in the presence of bidder's representatives who choose to attend 2:00 PM on 29 March 2022 at the office of HIB, Teku, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security as mentioned above which shall be valid for minimum 30 days beyond the bid validity period.
- 7. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.

If bidder wishes to submit the Cash Security, the cash should be deposited in Account of Financial Comptroller General Office, Tripureshwor Deposit Account No-1700100102030000, Office Code No: 370313501 at Rastriya Banijya Bank, Teku Branch and submit the receipt of the deposited amount of cash along with the Bidding document.
